Club member John Lighthouse scored 92 for his exhibit “Using the Documents of Commerce to Fund the Civil War 1862-1872”. At the Great American Stamp Show (GASS) in Cleveland last year. John indicates that this is his highest score yet.

POLAND MINIATURES WITH TABS

Poland has printed various stamps depicting art, with tabs including a description of the art or artist on the stamp.

I recently acquired a set of Poland, Scott 1748-1755, depicting miniature portraits, from our dealer member Jim Myers of Stamps Universal at a recent TSDA bourse. Thank you, Jim!

Frankly, I had not been aware these stamps were issued with tabs. The tabs themselves all read (in translation) "Miniature Portraits - Jewels of Great Painting". I was disappointed that each tab did not say something about the portrait on the attached stamp. So I am providing a description of the portraits below:

1748. **Aleksander Orłowski** (1777 – 1832) was a Polish painter and sketch artist, and a pioneer of lithography in the Russian Empire. This is a self-portrait.
1749. **Jan Matejko** (1838 – 1893) was a Polish painter, a leading 19th-century exponent of history painting, known for depicting nodal events from Polish history. This is a self-portrait.

1750. **Stefan Batory** (1533 – 1586) was Voivode of Transylvania, Prince of Transylvania, and King of Poland and Grand Duke of Lithuania. The painter is anonymous.
1751. **Maria Leszczyńska** (1703 – 1768), also known as Marie Leczinska (French), was Queen of France as the wife of King Louis XV. The painter is anonymous.
1752. **Maria Walewska** (née Łączyńska) (1786 – 1817) was a Polish noblewoman in the court of Napoleon I who used her influence to sway the emperor towards the creation of an independent Polish state. The painter was Marie-Victoire Jaquotot (1772 – 1855).
1753. **Tadeusz Kościuszko** (1746 — 1817) was a Polish-Lithuanian military engineer, statesman, and military leader who became a national hero in Poland, the United States, Lithuania, and Belarus. Painted by Jan Rustem (1762 – 1835), a painter of Armenian ethnicity who lived and worked in the territories of the Polish-Lithuanian Commonwealth.
1754. **Samuel Bogumił Linde** (1771, in Toruń – 1847) was a linguist, librarian, and lexicographer of the Polish language. He was director of the Prussian-founded Warsaw Lyceum during its existence and an important figure of the Polish Enlightenment. Giuseppe Landolfi painted this portrait miniature.
1755. **Michael Ogiński** (1765 – 1833) was a Polish diplomat and politician, Grand Treasurer of Lithuania, and a senator of Tsar Alexander I. He was also a composer of early Romantic music. Nanette Windisch, née Rosenzweig, (1757-1807) of Austria was the painter.

Using the Documents of Commerce to Fund the Civil War 1862 – 1872

PURPOSE

This **Revenue Fiscal History** exhibit is focused on the documents taxable under **Schedule B** of the Revenue Act of 1862 and its subsequent amendments. **Proprietary articles subject to taxes specified on Schedule C are excluded from this exhibit.**

BACKGROUND

After the Civil War broke out in 1861, Congress passed sweeping new tax measures, including the **Revenue Act of July 1, 1862**, creating a wide variety of new taxes in an effort to offset the cost of the Civil War. As part of this revenue collection effort, the first federal adhesive revenue stamps were printed in 1862 by **Butler & Carpenter** of Philadelphia and were issued by the U.S. Government for use in the tax year beginning on 10/1/1862. Almost every document produced was required to be stamped, resulting in an interesting array of material depicting life during the Civil War.

TREATMENT

First Issue revenue stamps were required during the first **nine years** and the bi-color **Second and Third Issues** were only used for **nine months** so most documents will show the First Issue. **Revenue stamped paper** was also authorized by this Revenue Act and began appearing in July, 1865. In 1872, all taxes were rescinded except for bank checks. The documents are **sequenced alphabetically by tax type, then type within usage (if applicable)**. In some cases, the dates are hidden from view, so transaction dates are provided for each document along with the pertinent tax rate. Incorrect taxes paid will be so noted. The right side of page headers show individual tax calculations used on the page.

Usage of Schedule C stamps such as Playing Cards and Proprietary and Postage Used as Revenue illustrate the confusion businesses and ordinary people experienced in trying to comply with the law. A few examples are shown in this exhibit. The penalties that could be levied were onerous in many cases and are noted within the description of each tax type.

The organization is predicated by the definitions in the Revenue Act of 1862 and its subsequent amendments. The government statutes and schedules, along with privately printed broadsides such as the one on the next page, all list the usages in alphabetical order, thus this exhibit follows their lead.

DEFINITIONS

OMU

Obligatory Matching Use (OMU) October 1 to December 25, 1862, when the matching stamp type was required for each document type. Very few OMU documents exist within this period.

EMU

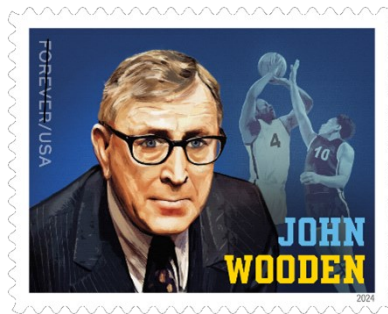
Early Matching Use (EMU) Matching stamp type used from December 25, 1862 through approximately June, 30 1863, when any documentary stamp could be used on any document.

Important events, information pertinent to an important person or place of historical importance or an important document fact is shown via a double red line box. Rare items are identified with an R8 (6-10 known) or R9 (2-5 known), also in a double red lined box.

USPS TO RELEASE STAMP HONORING JOHN WOODEN



Legendary coach John Wooden (1910-2010) led the University of California, Los Angeles (UCLA) Bruins to a record-setting 10 Division I men's basketball national championships. Often considered the greatest coach in the

history of American sports, Wooden coached the Bruins to 88 consecutive wins and four perfect (30-0) seasons. The stamp features a portrait of Wooden. In the "UCLA blue" background, a player defends a shot. The numbers on the two players' jerseys, 4 and 10, evoke the Bruins' four perfect seasons and the 10 national championships during Wooden's tenure. Antonio Alcalá, an art director for USPS, designed the stamp using original artwork by Alexis Franklin.
